The Officers who relieve the aforesaid nominated Judicial Officers are required to hold full additional charge of the additional post, till the nominated Judicial Officers take charge of their respective posts, after completion of the two-day course.

The nominated Officers from outstations are permitted to claim T.A./D.A. in this regard, as per rules in force.

The absence of the Officers attending the said Two-day Refresher Course from the Headquarters / Office in this regard, is treated as on "Other Duty".

The aforesaid nominated officers are informed that any request for exemption from participating in the said programme will not be entertained.
